GENERAL PRICE LIST

These prices are effective as of November 1, 2021. (Prices are subject to change without prior notice). The goods and services shown below are those we can provide to our customers. You may choose only the items you desire. However, any funeral arrangements you select will include a charge for our basic services and overhead. If legal or other requirements mean you must buy any items you did not specifically ask for, we will explain the reason in writing on the statement we provide describing the funeral goods and services you selected. Certain funeral services may be provided off-premises by other funeral service providers.

Professional Services of Funeral Director and Staff

• Basic Services of Funeral Director and Staff \$ 1.650 This fee for our basic services and overhead will be added to the total cost of the funeral arrangements you select. (This fee is already included in our charges for direct cremations, immediate burials, and forwarding or receiving remains.) Our services include staff to respond to initial request for services; photo identification; preparation of necessary authorizations and permits; recording vital statistics; state-required cremation permits, and mailing cremated remains by U.S. Mail. Also included in this charge are overhead expenses relative to our facilities such as professional licensing, legal, and accounting fees, insurance, record keeping, secretarial and administration expenses.

Funeral Home Facilities

- Facilities and staff for visitation and viewing Our services include: visitation setup, use of visitation room for up to four hours, display of floral arrangements and supervision and attendance during the gathering, viewing, visitation, or wake.
- Facilities and staff for funeral ceremony Our services include: coordinating the funeral arrangements, supervision of funeral, staff to coordinate the funeral ceremony, supervision of committal or other disposition service, setup and use of facilities for funeral ceremony.
- Facilities and staff for memorial service \$ 650 Our services include: coordinating the memorial service, supervision of the memorial service, staff to attend the memorial service, setup and use of facilities for memorial service.
- Equipment and staff for graveside service Our services include: coordinating the funeral arrangements at graveside, supervision of the graveside service, equipment and staff necessary to conduct the graveside service.

Embalming

Embalming is not required by law. Embalming may be necessary, however, if you select certain funeral arrangements such as a funeral with viewing. If you do not want embalming, you usually have the right to choose an arrangement that does not require you to pay for it, such as direct cremation or immediate burial.

Our fee for basic cremation services of funeral director and staff includes but is not limited to, staff to respond to initial request for service; preparation and filing of necessary authorizations and permits; transfer of deceased to funeral home, photo identification; local transportation to crematory, and crematory fee. This charge does not include the use of facilities and staff or any visitation or ceremony, public or private, prior to the cremation. State and local laws do not require a casket for direct cremation. If you want to arrange a direct cremation, you can use an alternative container. Alternative containers encase the body and can be made of materials like fiberboard or composition materials (with or without an outside covering). The containers we provide are made of cardboard.

Immediate Burial

\$ 2,450 to \$ 3,845

This charge for immediate burial includes professional services of funeral director and staff; transfer of deceased to funeral home; local transportation to the cemetery. This charge does not include the use of facilities and staff or any visitation or ceremony, public or private, prior to burial. Burial will be scheduled at the mutual convenience of the funeral home and cemetery, with no family or friends present.

Forwarding Remains to Another Funeral Establishment \$3,545 This charge includes: transfer of deceased to funeral home,

basic services of staff, embalming, utility vehicle for gathering necessary authorizations, and local transportation to airport. This charge does not include casket, shipping container, visitation, and rites or ceremonies prior to forwarding of the remains.

Receiving Remains from Another Funeral Establishment \$ 2,345 This charge includes: transfer of deceased to funeral home, transportation of deceased to cemetery, and basic services of staff. This charge does not include visitation, rites or ceremonies.

• Outer Burial Containers \$ 1,295 to \$ 1,295 A complete price list will be provided at the funeral establishment. In most areas of the country, state or local law does not require you to buy a container to surround the casket in the grave. However, many cemeteries require that you have such a container so that the grave will not sink in. Either a grave liner or a burial vault will satisfy these requirements.
